PROPOSED BOARD ACTION

Consider for Approval the Doctor of Physical Therapy (DPT) at Florida Gulf Coast University, CIP Code 51.2308

AUTHORITY FOR BOARD OF GOVERNORS ACTION

BACKGROUND INFORMATION

Florida Gulf Coast University (FGCU) is requesting authority to convert its Physical Therapy program to the doctoral level. The proposed DPT would replace the Master of Physical Therapy (MPT) degree program currently accredited by The Commission on the Accreditation of Physical Therapist Education (CAPTE). The change of degree level is driven by the need to remain competitive in student recruitment and also to be prepared when CAPTE begins to require doctoral level programs for accreditation. The curriculum for the DPT would consist of 115 credit hours, distributed across six tracks of required courses. The proposed program length and curriculum compare favorably with programs previously implemented at Florida universities, as well as programs implemented in other states. It would be necessary for FGCU to gradually increase the number of faculty as the DPT is implemented, with two 12-month full-time physical therapy faculty by Fall 2008, and two affiliate faculty by Fall 2009. If the DPT is approved, the first DPT students would be enrolled starting in Fall 2008.

- The expectation that FGCU could double its physical therapy cohort group size from 12 to 24 once it moves to the DPT may be somewhat optimistic. (page 9)
