General Revenue Collections for November 2007

General Revenue (GR) collections for November 2007 were \$21.7 M under the new estimates adopted by the General Revenue Estimating Conference (GR REC) on November 14, 2007. Sales Tax GR was \$16.1 M under the new estimate for the month. The components of Sales Tax falling short of the new estimates were Business (\$16.5 M or 4.8% under estimate), Consumer Non-Durables (\$15.8 M or about 3% under estimate), Other Durables (\$7.5 M or about 6% under estimate), and Tourism (\$3.2 M or about 1% under estimate). The Building component was \$2.4 M (about 2.4%) over estimate, with the Automobiles component right on estimate at \$0.2 M over.

The remaining GR sources were a mixed bag. Intangibles Taxes fell \$6.3 M under the new estimate, while total collections in the Documentary Stamp Tax came in \$21.1 M under the new estimate. Both of these sources are being affected by continuing weakness in the housing market. Insurance Premium GR was \$10.5 M under estimate due to receipt of revenues from the Surplus Lines component last month instead of this month. Service Charges to GR were \$11.4 M under estimate, with timing of transfers to GR from many of the smaller sources the culprit.

On the upside, Interest Earnings continued its run, coming in \$15.9 M over the new estimate for the month. As noted last month, higher balances and gains in the external portfolio continue to bolster the source. The Corporate Income Tax was \$9.7 M over estimate in this relatively light month for collections.

Beverage Taxes were strong, coming in \$5.2 M over estimate.

Refunds were also over estimate, but Refund overages reduce GR's net bottom line. Refunds were \$6.7 M over estimate for the month due to higher than expected Corporate Income Tax refunds.

To summarize, Net GR collections for November were \$21.7 M under estimate for the month and for the 2007-08 fiscal year. The table below is based on the new monthly estimates from the November 14, 2007 GR Estimating Conference.
