#21. State your experience and interests or elements of your personal history that qualify you for this appointment.

I have amassed both professional and personal experience that I feel would add a great deal to the collective knowledge and skill of the B.O.T. for Florida A&M.

Professional: The education I obtained from Florida A&M provided me with a strong foundation for professional achievement.
