This program has been inactive since 2001 when the last student graduated. Applicants interested in pursuing a doctoral degree in this area may do as a concentration within the doctoral program in Higher Education Administration (CIP Code 13.046), which is still in effect. *Please note that the Masters degree in Student Personnel in Higher Education has the same CIP code as the doctoral program, and it is NOT being terminated.*

2. Indicate on which campus(es) the program is being offered and the extent to which the proposed termination has had or will have an impact on enrollment, enrollment planning, and/or the reallocation of resources.

The program was offered at the University of Florida in the Department of Educational Administration and Policy. The proposed termination will have no impact on enrollment, enrollment planning, or allocation of resources since no students have been enrolled since 2001.
