

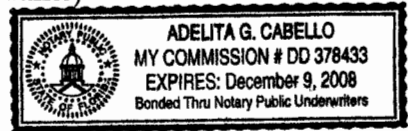

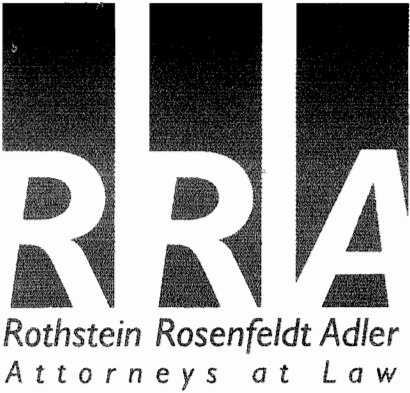
MEMORANDUM
