State University System Summary of Issues in the Proposed 2004-2005 Education Conference Report

The following is a brief narrative of the issues in the 2004-2005 Conference Budget Recommendation for the State Universities. The numbers correspond to the issues on the Major Issue Summary document.

- 1. This issue, 2003-2004 Appropriation, is the total amount appropriated in the Educational and General budget entity in the 2003 General Appropriations Act (GAA).
- 2. 2003-2004 Adjustments to the Base
- 3. The State contribution for employee Retirement Rates increased from 5.76% to 7.39% effective July 1, 2003. A Lump Sum appropriation for all agencies, including universities, was made in the Administered Funds section of the 2003 GAA (Specific Item 1950B).
- 4. State employees received a Salary Increase effective December 1, 2003. A Lump Sum appropriation for all agencies, including universities, was made in the Administered Funds section of the 2003 GAA (Specific Item 1945L).
- 5. The States share of **Health Insurance** premiums increased effective December 1, 2003. A Lump Sum appropriation for all agencies, including universities, was made in the Administered Funds section of the 2003 GAA (Specific Item 1947).
- 6. The universities' share of Casualty Insurance Premiums increased by \$668,294 effective July 1, 2003. These additional funds were provided to the universities with payment made to the State Division of Risk Management for increases in workers' compensation and general liability insurance costs.

- 7. This is the total 2003-2004 Adjusted Appropriation for the eleven state universities.
- **8. 2003-2004 Non-recurring Appropriations** are deducted from the 2003-2004 appropriation resulting in the base budget to which new requests are added. The following issues totaling \$67,756,289 are funded with non-recurring resources:

10. Cost-to-Continue Programs

- 11. The appropriation for the health insurance premium increase that went into effect on December 1, 2003 will only cover the seven months associated with this fiscal year. The additional five months needed for 2004-2005 is known as the Annualization of 12/1/03 Health Insurance Increase.
- 12. The appropriation for the salary insurance increase that went into effect on December 1, 2003 will only cover the seven months associated with this fiscal year. The additional five months needed for 2004-2005 is known as the Annualization of 12/1/03 Salary Increase.
- 13. 2003-2004 Plant Operations & Maintenance (PO&M) for Phased-In Space, \$2,708,577 is the balance of resources required to support the annualized operational costs for 1.5 million gross square feet of new space that comes on-line throughout 2003-2004.

- 14. 2004-2005 PO&M for New Space, \$9,130,839 is to support operational costs for 1.7 million gross square feet of new educational space that comes on-line at various times during 2004-2005. These projects have substantial completion dates before June 30, 2005.
- 15. Florida Center for Reading Research, \$1,593,600 is for the continued support for this Florida State University Center whose mission is to discover, create, catalog, disseminate and apply the most current reading research in Florida Classrooms. This issue was funded with non-recurring resources in 2003-2004. Therefore, this is a restoration of current year's funds.
- 16. Major Gifts Matching, \$94,880,397 (of which \$1.7 million is in the base) is to support the major gift matching program. The program provides state matching funds which are an incentive for private support for university scholarships, professorships, and endowed chairs. This amount eliminates the current backlog through December 31, 2003.
- 17. Courtelis Facilities Matching Program, Funds for this program are included in the fixed capital outlay section of the budget.
- 18. Florida Office of Civil Rights, \$1,000,000 is to be used for initiatives identified in the Florida/OCR Partnership Agreement. In 1995, Governor Lawton Chiles and Secretary of Education Richard Riley developed a collaborative approach to evaluate access of minority students to higher education.
- 19. Total cost-to-continue.
- 20. Access to Higher Education

- 21. Board of Governors requested \$82.2 million for Enrollment Growth/Over-Enrollment funding for 11,496 full-time equivalent (FTE) students.
- **22.** Enrollment Growth/Over-Enrollment, funding of \$49,892,017 will fund 9,103 FTE students.
- 23. Medical Education, \$4,313,564 is for the continued implementation of the College of Medicine at Florida State University, which will fund an additional 60 FTE students. This non-traditional model of medical education focuses on a partnership with existing community hospitals, physicians, and other health care providers.
- **24.** Law School, \$1,000,000 is for the continued implementation of the Florida A&M University Law School located in Orlando. An additional 98 FTE students will be enrolled beginning in the fall of 2004.
- 25. Total Access to Higher Education
- 26. State Critical Needs
- 27-28. Funding for these issues is not included in the conference recommendation.
- 29. Total State Critical Needs
- 30. Research/Economic Development/Graduate Education
- 31-33. Funding for these programs is not included in the conference recommendation.
- **34.** Requested funding for **Research/Economic Development** was only partially funded in the conference recommendation. See items 35 and 36 for issues that were included in the Board of Governor's recommendation.

- 35. This funding of \$2,000,000 for IFAS Citrus Research will focus on the development of more pest resistant plans and the development of new plant varieties more appealing to the consumer. Mapping the citrus genome will allow researchers to more easily do both of these cutting the breeding time into almost a quarter of what it would normally require. Citrus canker is an example of a pest or pathogen that will most likely require the development of a disease-resistant variety of citrus.
- 36. Cancer is a leading cause of death and Florida's cancer rates are among the highest in the country. To address this problem, the University of Florida has initiated development of a cancer education, research and treatment center that will have statewide and nationwide impact. The proposed Cancer Education, Research Treatment at UF Health Science Center will implement an aggressive plan of recruitment to reach the critical mass of faculty and research programs necessary to achieve National Cancer Center (NCI) designation as a Comprehensive Cancer Center.
- **37.** Funding for **Technological Expansion** at Florida Gulf Coast University and New College of Florida is not included in the conference recommendation.
- 38. Total Research/Economic Development/Graduate Education

39. Other Issues

- **40-43.** The funding for these issues, as recommended by the Governor, is not included in the conference recommendation.
- **44.** The funding of \$500,000 for the **St. Lucie Charter School** at Florida Atlantic University (FAU) will be used to plan for a unique K-12 Developmental Research Charter School to be developed in partnership with the Core Communities, Inc,

- and located in St. Lucie County, a short distance from FAU's Treasure Coast Campus.
- 45. The funding of \$500,000 for New College of Florida (NCF) will be used for Student Scholarships. These funds were previously provided by the USF before NCF became the 11th state university.
- **46.** Virgil Hawkins Scholarship Phase-out of \$207,165 is a reduction in the base budget for UF and FSU to eliminate this scholarship program. The 2003-2004 school year is the final year of the program. It is the general consensus that this program is no longer needed since the opening of the FAMU and FIU law schools.
- 47. The FAU/UM Medical Partnership funding of \$2,300,000 will complete the base funding for the program in Biomedical Sciences and the Partnership for Quality Medical Education. The innovative partnership with the University of Miami School of Medicine (UMSM) allows the School of Medicine to increase the capacity of its entering classes by 32 students who will receive their first-year and second-year training in the Charles E. Schmidt Center for Biomedical Sciences at FAU. Under this exemplary model, the students will subsequently join their UMSM-based counterparts in their third and fourth year clinical rotations.
- 48. The UCF Project "E" funding of \$4,200,000 is a key part of a financial package aimed at enticing the nation's largest video-game maker to expand in Central Florida. These funds would be used to launch a specialized program at the University of Central Florida to train prospective employees of Electronic Arts (EA), the California-based game company. The UCF program is part of a \$41 million package of incentives that Orlando, Orange County and others are trying to put together to push EA to expand locally. EA, which makes such games as the Madden NFL franchise, is looking to broaden its operation, possible creating 775

more jobs. EA currently employs 275 people at a Maitland subsidiary called Tiburon.

- **49.** An Administrative Reduction of \$300,000 at UF is recommended.
- **50.** Additional general operating funds of \$300,000 are provided for the UF **School of Veterinary Medicine**.
- **51.** The requested transfer of the **MPLE** program to the Office of Student Financial Assistance was not included in the conference budget.
- **52.** This reduction of \$670,863 for the **MPLE Phase-out** leaves \$885,340 in the base for the final year of this program. It is the general consensus that this program is no longer needed since the opening of the FAMU and FIU law schools.
- 53. The USF-FIU Medical Partnership funding of \$1,000,000 will be used to prepare outstanding students interested in medicine by providing them with a sound baccalaureate degree foundation for medical school through an advanced curriculum, mentoring, and appropriate resources, in a competitive and interdisciplinary environment. This program is a collaborative effort between the FIU Honors College and the USF Medical School Education Program.
- **54. IFAS Local Extension Matching** provides funds to match county funds to fill 26 county agent positions that are currently vacant.
- 55. The funding of IFAS Teaching Partnerships will continue to leverage new and existing partnerships with other SUS partners, private universities, and community colleges to serve place-bound students desiring basic and advanced degrees in agricultural and natural resource related programs. These partnerships will be expanded in Ft. Pierce, Homestead, Ft. Lauderdale, Milton, Apopka, Ft Myers, and Hillsborough County.

- **56.** This issue transfers funds for the **Ringling Museum** to the Educational and General budget from the Department of State's budget.
- 57. Funding of \$843,218 for IFAS Equipment at the Balm Facility will be used to purchase equipment at the new Gulf Coast Research and Education Center being built in Balm, Hillsborough County. It consolidates the operations of the current labs in Bradenton and Dover. This facility will serve the tomato, strawberry, and horticulture producers of that region.
- **58.** Total Other Issues
- **59.** The total conference recommended increase over the 2003-2004 adjusted appropriation is \$134 million.
- **60.** The total conference recommended percentage increase over the 2003-2004 adjusted appropriation is 6.83%
- 61. Additional Major Gift Trust Fund budget authority is included.
