## MINUTES FLORIDA BOARD OF GOVERNORS FOUNDATION, INC. NATIONAL HIGH MAGNETIC FIELD LABORATORY FLORIDA STATE UNIVERSITY TALLAHASSEE, FLORIDA APRIL 30, 2003

Mr. Thomas F. ## 1. <u>Consideration of Amended Articles of Incorporation, Florida Board of Governors</u> Foundation, Inc.

Ms. Moll moved that the members of the Foundation approve the amended Articles of Incorporation for the Board of Governors Foundation, Inc., as presented. Ms. Parker seconded the motion, and members of the Foundation concurred.

#### 2. Consideration of Amended Bylaws, Florida Board of Governors Foundation, Inc.
