

21. I have practiced law for 40 years in the area of corporate law and business transactions. In my practice I have routinely advised public and private business entities and their governing boards in matters of corporate governance and fiduciary responsibility. I have also served on a number of not-for-profit organization boards in a leadership capacity. I believe that background provides valuable experience on which to draw should I be selected for this position.

In addition, it has been my privilege from 2004 through 2007 to serve as Chair of the Board of Directors of Tampa General Hospital, the USF College of Medicine's primary teaching hospital and an important strategic partner with USF in the advancement of medical education and healthcare in the USF service region. In that capacity, I have had the opportunity to work with officials at USF and gain valuable insight into the operations and governance mechanisms of the University.
