ORDER

THIS CAUSE, having come on to be heard before me on the Defendant's Sworn Motion to dismiss the above cause on the grounds that there are no material disputed facts, and the undisputed facts do not establish a *prima facie* case of guilt against him, pursuant to Florida Rules of Criminal Procedure, Rule 3.190(c)(4) and the Court being otherwise fully advised in the premises, it is hereby,

ORDERED AND ADJUDGED, that the Defendant's Motion to Dismiss is **GRANTED** and as grounds therefore, the Court makes the following findings of fact and law:

The defendant was charged with resisting an officer without violence, pursuant to FLORIDA STATUTE 843.02, for *allegedly* "interfering with an active DUI investigation." See Information For Case Number B09-4632.

The Defendant's Sworn Motion to Dismiss was filed on June 12, 2009, and scheduled for a hearing on July 8, 2009. Pursuant to Rule 3.190 (d), the State had to file a traverse or demurrer within a reasonable time before said hearing. Factual matters alleged in a Motion to Dismiss filed under Rule 3.190 (c)(4) shall be considered admitted unless specifically denied in a traverse. The State here failed to

file any response whatsoever to the Sworn Motion to Dismiss. Accordingly, the Court finds that the facts alleged in the Defendant's Sworn Motion to Dismiss are admitted.

It was uncontested that Mr. Caruncho is an attorney, licensed to practice law in the State of Florida. It is similarly uncontested that on the date in question, Mr. Caruncho went to a local gas station to obtain gas for his girlfriend, Samara Kharfan, whose car had run out of gas. Upon returning to where Ms. Kharfan was stopped, Mr. Caruncho encountered Officer Cristino Perez, who had stopped to assist Ms. Kharfan. Officer Perez told Mr. Caruncho to "go back to your vehicle" and that he was "conducting a criminal investigation". Mr. Caruncho responded that he was her attorney and he advised Ms. Kharfan of her legal rights. Based upon Mr. Caruncho's action of advising Ms. Kharfan of her legal rights, the officer placed him under arrest for resisting an officer without violence.

Mr. Caruncho's actions in attempting to provide his client with legal advice cannot be construed as a violation of Florida Statute 843.02. See D.A.W. v. State, 945 So. 2d 624 (Fla. 2d DCA 2006) (juvenile could not be adjudicated for obstructing justice under § 843.02 Fla. Stat. because the fact that the juvenile stood 15-30 feet away from the officer and yelled harassing comments was not enough to support a finding of obstruction); Jones v. State, 955 So.2d 1208 (Fla. 4th DCA 2007) (court erred in denying judgment of acquittal where the State failed to show that defendant made any affirmative actions that constituted obstruction or resistance of a lawful duty). And see Lee v. State, 368 So.2d 395 (Fla. 3d DCA 1979) (defendant had a common law right to resist an unlawful arrest without violence).
