1. <u>Call to Order and Opening Remarks</u>

2. <u>SUS PECO Project Presentations</u>

3. P3 Guidelines

Chairman Huizenga called on Mr. Chris Kinsley, Assistant Vice Chancellor for Finance and Facilities, to discuss the Public Private Partnership (P3) Guidelines. Mr. Kinsley discussed the three 2018 P3 Projects that have made it to staff review level, of which two were converted by the university to bond deals, with the one P3 project remaining still outstanding. During the same time frame, two debt deals were fully approved by the Board. Mr. Kinsley then discussed and answered questions from the Committee regarding the potential amendments to the Public Private Partnership Guidelines.

4. <u>Housing Study</u>

Mr. Chris Kinsley, Assistant Vice Chancellor for Finance and Facilities, discussed the Housing Study and the data collected from each university regarding the occupancy and rate information for Fall 2018, as well as Fall 2017, for historical comparison purposes. Mr. Kinsley further discussed how keeping housing occupancy up is important for the university and is related to student success. Mr. Kinsley answered questions from the Committee.

5. <u>Concluding Remarks and Adjournment</u>

Chairman Huizenga concluded stating the next phase of the process is the development of the PECO priority list and encouraged feedback or comments to the staff. There being no further business, Chairman Huizenga adjourned the meeting at 2:26 p.m. (ET), October 16, 2018.
