## **BACKGROUND INFORMATION**

The requested budget provides the State University System of Florida continued capital outlay support and has been prepared in accordance with statutory requirements and guidelines adopted by the Board of Governors. The Board amended the FCO LBR on November 8, 2018, meeting; staff are proposing various adjustments to the FCO LBR as further described below.

# **Specific Fixed Capital Outlay Appropriation Requests**

The previous adopted PECO budget was in accordance with the estimates adopted by the August 1, 2018, PECO Revenue Estimating Conference. The December 4, 2018, estimates revise the amounts downwards. Staff recommends a pro-rata adjustment to all projects.
