Legislative Authorization Requests

From the unexpended balance of funds appropriated in Specific Appropriation Section 34, Chapter 2017-233, Laws of Florida, for the renovation of the University of Florida Music Building (HB 2663), \$5,927,338 shall revert immediately and is appropriated in the same category as the planning and construction of the new Music Building at the University of Florida.

From the unexpended balance of funds appropriated in Specific Appropriation Section 34, Chapter 2017-233, Laws of Florida, for the Florida State University STEM Teaching Lab, \$4,233,813 shall revert immediately and is appropriated in the same category to the Interdisciplinary Research Commercialization Building (IRCB) at Florida State University.

The University of South Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, an amount not to exceed \$9,267,417 for the Interdisciplinary Science – Research Lab Build Out.

The University of South Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations to the USF Sarasota/Manatee campus, which may exist as of July 1, 2019, in an amount not to exceed \$2,800,000 for the renovation and expansion of the USF Sarasota/Manatee College of Hospitality & Tourism Leadership space on that campus.

The University of West Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$8,000,000 for Campus Roof Replacement.

The University of West Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$3,200,000 for the Central Utility Plant Switchgear Replacement.

The University of North Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$5,000,000 for the Renovation of Roy Lassiter Hall.

The Florida State University is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$1,500,000 towards planning and design of the FAMU/FSU College of Engineering Building C.

The Florida Agricultural and Mechanical University is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$1,500,000 towards planning and design of the FAMU/FSU College of Engineering Building C.

Florida A&M University is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$7,000,000 for Interdisciplinary Research Lab Buildout.

The University of Central Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$20,379,277 for the Renovation of Engineering Building I.

The University of Central Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$8,681,000 for the Biological Sciences Building HVAC Replacement and Other Repairs.

The University of Central Florida is hereby authorized to expend reserve or carryforward balances from operational and programmatic appropriations which may exist as of July 1, 2019, in an amount not to exceed \$7,800,000 for the Mathematical Sciences Building HVAC Replacement.
