#### <u>Purpose</u>

Explore whether Florida's State Universities are affordable for all undergraduate students who are qualified and motivated to attend, taking into consideration the three main components of affordability (tuition, state appropriations, financial aid).

#### **Guiding Questions**

- 1. What is the cost of attending an SUS institution?
- 2. How does that compare to other states? Other sectors?
- 3. Is the cost of attending an SUS institution affordable for all income groups?
- 4. If not, what can we do to enhance affordability?

#### Scope of the Study

Within one year, complete the Study, based upon the Guiding Questions, and develop any necessary policy recommendations that arise from the findings of the study. Limit recommendations to strategies and activities actionable by the SUS.




## What is the cost of an undergraduate education at an SUS institution?



#### **System Average Cost of Attendance**


For Full-Time, Undergraduate Florida Residents in the Fall and Spring of 2014-15



#### **System Financial Aid Trends** by Award Type for Undergraduates



to Undergraduates by Family Income Group




