Board Regulation 8.004 Academic Coordination

(1) To facilitate collaboration, articulation, and coordination of academic program delivery across the State University System, the Office of the Board of Governors shall coordinate with the Council of Academic Vice Presidents to conduct an annual review of all current academic degree program offerings, as well as university plans regarding the addition or termination of any degree programs.

The CAVP Academic Coordination Project Work Group:

- 1) Meets at least 4 times a year, twice in-person
- 2) Includes academic affairs leaders from every campus, appointed by and reporting back to the Provost
- Considers all new program approval requests and notes whether there are concerns
- 4) Reviews all programs at all levels every 3 years to assess productivity



Results of the 8/12/2015 Review of Programs

1,796 Programs in the SUS analyzed by level and 6-digit CIP

Thresholds for Graduates within 5 Years:

Bachelor's: 30 Master's: 20 Specialist and Doctorates: 10

Guiding Principles for Review:

- 1. Alignment with institutional, Board of Governors, and state priorities
- 2. Documented need (including student and workforce demand)
- 3. Unnecessary duplication in the context of proximal delivery
- 4. Adequate resources to deliver the program
- 5. Quality
