Five Universities Currently Use Canvas

University	Contract Expiration Date?	Intend to Remain with Canvas?	Intend to Convert Contract to Master Agreement?
FGCU	July 2016	Yes	Yes
Polytech	April 2019	Yes	Yes, assuming terms are better than could be negotiated separately. Willing to attempt to negotiate for an early contract termination in order to convert.
UCF	June 2016	Yes	Currently evaluating licensing options, which include the Board's Master Agreement.



Five Universities Currently Use Canvas

University	Contract Expiration Date?	Intend to Remain with Canvas?	Intend to Convert Contract to Master Agreement?
UF	June 2018	Yes	Will evaluate all options at renewal time.
USF	July 2018	Yes	Yes



Five Universities Currently Use Blackboard

University	Contract Expiration Date?	Intend to Migrate to Canvas?	Intend to Convert Contract to Master Agreement?
FAMU	2017	TBD	Will convene an Evaluation Committee in spring 2016, with recommendations due spring 2017. Has partnership with FSU for Blackboard in Joint FAMU/FSU College of Engineering.
FSU	June of each year*	TBD	The Provost has commissioned an Opt-In LMS Feasibility Workgroup to evaluate the benefits and features of Canvas, as well as any limitations. If Canvas is recommended, a review of resources will determine a transition plan and timeline, using the Master Agreement.

^{*} Perpetual license with annual support requirements to continue use. Annual support agreement expires on June 30 each year. Blackboard has been FSU's provider since 1999.



Five Universities Currently Use Blackboard

University	Contract Expiration Date?	Intend to Migrate to Canvas?	Intend to Convert Contract to Master Agreement?
FAU	June 2017, - option of continuing for 2 more years	TBD	Currently conducting a comprehensive LMS review, which will be completed by April 30, 2016. Evaluation includes review of both Master Agreement and the Unizin Agreement to determine which would be best for FAU.
FIU	July 31, 2017	TBD	Currently working with Canvas representative to evaluate a migration plan and cost of a new contract. Preliminary testing to assess the level of effort to migrate and plan a potential timeline to Canvas. Would use either Master Agreement or Unizin, dependent on which offers the greater benefit to FIU.



Five Universities Currently Use Blackboard

University	Contract Expiration Date?	Intend to Migrate to Canvas?	Intend to Convert Contract to Master Agreement?
UNF	June 2017	Yes	Just completed an evaluation process, with faculty recommending adoption of Canvas. UNF is reviewing contract options, and will probably use the Master Agreement.



One University Currently Uses Moodle

University	Contract Expiration Date?	Intend to Migrate to Canvas?	Intend to Convert Contract to Master Agreement?
New College	No contract with Moodle, because it's an open source LMS. Hosting contract ends in August of every year.	Yes	Yes. Will begin migrating in 2016-17, with full migration to occur in the 2017-18 academic year.



One University Currently Uses Desire2Learn

University	Contract Expiration Date?	Intend to Migrate to Canvas?	Intend to Convert Contract to Master Agreement?
UWF	August 2017	Yes	Have not yet seen the Master Agreement. After review, may have additional questions. Target date for starting with Canvas would be Spring 2018.
