1993 – 2021 UNIVERSITY OF NORTH FLORIDA, JACKSONVILLE, FLORIDA

The University of North Florida is a public university located in Jacksonville, FL. A member institution of the State University System of Florida, UNF is accredited by the Southern Association of Colleges and Schools Commission on Colleges to award baccalaureate, masters and doctorate degrees. The University currently has an enrollment of approximately 17,000 students. UNF is organized into five colleges that offer more than 50 undergraduate degree programs and about 30 graduate-degree programs.

2019-2021: Professor and Dean Emeritus

- Taught two courses per semester both face to face and recently remotely with Instructional Questionnaire Scores for overall rating of instructor from 4.80 – 4.91
- Reexperienced the faculty role and connected with students and colleagues as a professor

2017 - 2019: Interim Provost and Vice President of Academic Affairs

- Integrated Student Affairs into the Academic Affairs Division saving over \$600,000
- Coordinated teams to improve student success rates
- Performance Based Funding metrics improved by 34% from 2017-2019
- Southern Association of Colleges and Schools re-accreditation visit ended one day early with no recommendations

- Oversaw college enrollment increase of 23% since 2009

- Added 3 doctoral programs (nursing, nutrition and physical therapy) and multiple master and baccalaureate programs
- Supported multiple international study abroad programs

- Community Nursing and Nutrition and Dietetics were awarded flagship program designation by UNF President Delaney

1991 – 1993 CONCORDIA UNIVERSITY AND WEST SUBURBAN COLLEGE OF NURSING, Oak Park, Illinois

Concordia University, a private liberal arts, institution had an enrollment of 1,700 students and West Suburban College of Nursing had an enrollment of 240 students. They offered one of the first joint programs in the nation accredited by both regional and professional accrediting bodies.

- Revised graduate and undergraduate curriculum to respond to concerns of National League for Nursing Accrediting Commission
- Received 9.21/10.00 rating when evaluated as an administrator by all full-and part-time faculty
- Awarded three grants supporting research endeavors (\$7,445 total)

KENNESAW STATE UNIVERSITY, MARIETTA, GEORGIA

Kennesaw State was one of the fastest growing Universities in the University of Georgia System.

Founded

in 1966, it had nearly 20,000 enrolled students.

1982-1989: Director, Baccalaureate Nursing Program, Associate Professor

- Developed new BSN program beginning with initial approval from the Georgia Board of Nursing and eventually achieving NLN accreditation
- First graduating class achieved 100% passing rate on NCLEX. Students' scores ranked second in the state among all schools and fourteenth in the nation among baccalaureate programs
- Voted 1987 Baccalaureate Nursing Teacher of the Year and finalist for the 1988 Kennesaw State College Distinguished Teaching Award
- Planned curriculum for proposed Master of Science in Nursing Program

Dekalb College was the major community college meeting the educational needs of Atlanta residents.
