Civil Discourse Outreach to K-12 Students & Teachers  UCF's Lou Frey Institute, in collaboration with colleagues from Illinois and the support of the McCormick Foundation, developed a course series called <i>The Guardians of Democracy</i> , is designed to prepare Florida's K-12 teachers to educate their students about civics. The course series helps teachers understand how to guide students in appropriate civil discourse with peers. The first course in the series provides the foundation: <i>Current and Controversial Issue Discussions</i> , which focuses on understanding the purpose, role, and function of civil discussion strategies as pedagogical tools to equip young people with the knowledge, dispositions, and skills to be "Guardians of Democracy" and to engage in civil dialogue with peers. The second course, <i>Simulations of Democratic Practices</i> , focuses on understanding simulations of democratic processes and how this pedagogical practice builds on what was learned in the previous course.	<b>✓</b>		✓	<b>✓</b>
