Criteria for selecting new programs

Section 1009.26, Florida Statutes & House Bill 5001



- ✓ Program of strategic emphasis in the **critical workforce gap analysis** category
- ✓ Must reflect **priorities** of the state
- ✓ Be offered at a **majority of state universities**
- ✓ Must not be from CIP code **09, Communication, Journalism, & Related Areas**

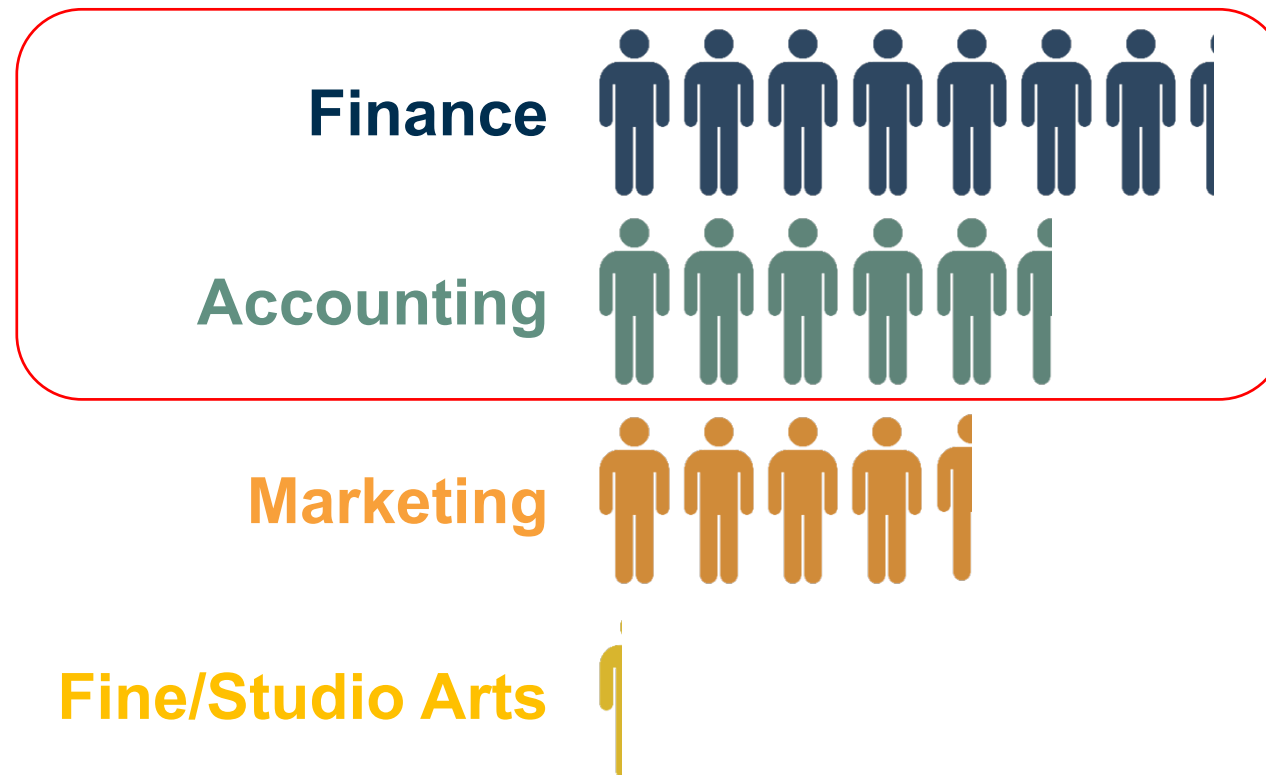
