Specialized Admissions



- ✓ Allows an institution to establish additional admission criteria for entry into undergraduate degree programs

Qualifying Criteria	Reaffirmation Required
Minimal Skills Required	Every 5 years
Limited Resources	Every 4 years
Program Accreditation	Every 4-5 years

Specialized Admissions Implementation Timeline



To request specialized admissions status for the 2023-24 Academic Year, institutions needed to apply by **October 1, 2022**
