

Three Year History of Presidential Selections and Interim Appointments

UF: President Sasse confirmed November 2022; selected by UF Board in November 2022 (search commenced March 2022). President Fuchs served until President Sasse took office in February 2023. *Board of Governor Representative: Charlie Lydecker*

FIU: President Jessell confirmed November 2022; selected by FIU Board in October 2022 (search commenced March 2022). Dr. Jessell appointed as Interim President by FIU Board in January 2022 after President Rosenberg stepped down. Board of Governors confirmed Dr. Jessell as Interim President in February 2022. Served as Interim President for 10 months. *Board of Governor Representative: Patricia Frost*

FAU: President Kelly's contract extension through December 2022 approved by Board in November 2022. Dr. Volnick appointed as Interim President by FAU Board to start service as Interim on January 1, 2023. Board of Governors confirmed Dr. Volnick as Interim President in November 2022 (for 1/1/23 start). FAU initiated a presidential search in January 2023. *Board of Governor Representative: Alan Levine*

UNF: President Limayem confirmed June 2022; selected by UNF Board in May 2022 (search commenced September 2021). Dr. Chally appointed as Interim President by UNF Board in August 2021. Board of Governors confirmed Dr. Chally as Interim President in September 2021. Served as Interim President for 11 months. *Board of Governor Representative: Kent Stermon*

USF: President Law confirmed March 2022; selected by USF Board in March 2022 (search commenced August 2021). Ms. Law appointed as Interim President by USF Board in August 2021 after President Currall stepped down. Board of Governors confirmed Ms. Law as Interim President in September 2021. Served as Interim President for almost 8 months. *Board of Governors Representative: Ken Jones*

FSU: President McCullough confirmed June 2021; selected by FSU Board in May 2021 (search commenced October 2020). President Thrasher continued to serve as President until President McCullough took office in August 2021. *Board of Governor Representative: Eric Silagy*

NCF: President Okker confirmed June 2021; selected by NCF Board in April 2021 (search commenced October 2020). President O'Shea continued to serve as President until President Okker took office in July 2021. President Okker's contract was terminated by NCF Board in January 2023 and Mr. Corcoran was appointed to serve as Interim President, with Dr. Thiessen serving in a temporary capacity as Interim President until Mr. Corcoran could commence employment with the college. Mr. Corcoran's term as Interim President commenced on March 1, 2023. NCF will be initiating a national search for a permanent president. *Board of Governor Representative: Alan Levine*

UCF: President Cartwright confirmed March 2020; selected by UCF Board in March 2020 (search commenced October 2019). Dr. Seymour appointed as Interim President

by UCF Board in March 2019 after President Whitaker resigned. Board of Governors confirmed Dr. Seymour in March 2019. Served as Interim President for one year. *Board of Governor Representative: Tim Cerio*

FGCU: Initiated a national search for a president in June 2022. President Martin is continuing to serve as president until a successor is selected. *Board of Governor Representative: Darlene Jordan*
