- 1) Data provided by each univeristy. Includes projects categorized as Critical Need, Deferred Capital Replacement & Renewal or major renovation/remodeling.
- 2) FAMU-FSU College of Engineering, FSU-Panama City and USF-St Petersburg were identified separately in the FY22-23 legislative appropriations. Florida Poly did not report any deferred maintenance on the original list.
- 3) Funding from the State's allocation from the federal Coronavirus State Fiscal Recovery Fund (Public Law 117-2) distributed as a nonrecurring appropriation from General Revenue.
- 4) The prorata allocations are based on the FY22-23 legislative appropriation allocations (as a %) to each university.
- 5) At a national level, aggregate cost escalation since 2021 exceeds 25%, based on Nonresidential building Final Cost Indices (i.e., including contractor margins) as of 8/17/23 of 8.2% (2021), 12.1% (2022), 5.4% (ytd 2023), per "*Construction Inflation 2023*", Construction Analytics website. The above FY24-25 Budget Request reflects the remaining balance of \$356M plus an additional \$99M to account for cost escalation (compounded annual inflation) since the original estimates.
