# Regulation 8.009, Educational Sites

## **Type III Campus**

- ✓ Typically provides a limited range of instruction, research activity, & student services
- ✓ Maintains enrollment between 300 & 1,000 students
- ✓ Facilities university-owned, university-leased or jointly used with another public institution

---

## **Special Purpose Center**

- ✓ Provides certain special, clearly defined programs or services, such as research or public service
- ✓ Facilities owned by the university

---

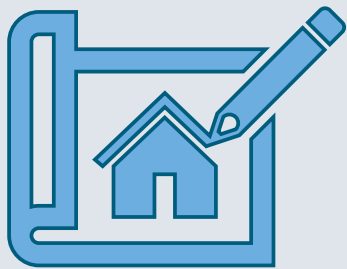
## **Special Purpose Site**

- ✓ Provides services of an educational or community outreach nature not leading to a postsecondary degree
- ✓ Facilities not owned by the university

# University of Central Florida-Ocala



## Reclassify UCF-Ocala from a Type III Campus to a Special Purpose Site



### Current Site Use

- A joint-use facility with the College of Central Florida
- Offered instruction leading to a Bachelor's in Elementary Education
- Discontinued instruction due to lack of demand



### Proposed Action

- Reclassify as a Special Purpose Site
- Maintain a DirectConnect coach to facilitate transition from College of Central Florida to UCF



### Impact

- No impact on university staff, faculty, or students

# University of Central Florida – Leesburg



## Close UCF-Leesburg, a Type III Campus



### Current Site Use

- A joint-use facility with Lake-Sumter State College
- Offered instruction leading to a Bachelor's in Elementary Education
- Discontinued instruction due to lack of demand



### Proposed Action

- Closure



### Impact

- University implemented a teach-out plan
- No impact on university staff, faculty, or students

# University of Central Florida-Palm Bay





## Close UCF-Palm Bay, a Type III Campus



### Current Site Use

- A joint-use facility with Eastern Florida State College
- Offered coursework for Bachelor's degrees in Psychology, Human Communications, Interdisciplinary Studies
- Discontinued instruction due to expansion of online presence & course relocations



### Proposed Action

- Closure



### Impact

- University implemented a teach-out plan
- No impact on university staff, faculty, or students

# University of Central Florida-South Orlando



## Close UCF-South Orlando, a Type III Campus



### Current Site Use

- 2 permanent unoccupied buildings on 20 acres of land
- Most recently, the site was used exclusively for testing



### Proposed Action

- Closure
- UCF signed a 50-year sublease with Orange County for the establishment & operation of a public park & recreational facility



### Impact

- University moved testing to sites with more modern facilities
- No impact on university staff, faculty, or students
