The excess hours metric is based on 110% threshold in statute

In 2019, the
Legislature
changed the
threshold from
110% to 120% to
reduce costs to
students

The Board can still have a goal using a different threshold

Consider Revising: Undergraduate Research

In Strategic Plan since 2011 but never measured due to data inconsistencies

In March, the Vice Presidents for Research worked with CAVP to develop a system-wide question

It is recommended that this question be added to senior exit survey at all 12 institutions








Percent of Baccalaureate Graduates Continuing Education or Employed






Graduation Rates for FCS AA Transfers (FT Only)





Comparison of FTIC & AA Transfer Students







Graduation Rates for FCS AA Transfers (FT Only)


