Affordability Performance Indicator and Goal: e-Texts and Open Educational Resources

Current Performance Indicator:

Availability of reduced cost electronic textbooks or accepted open educational resources (OERs)

Current Goal:

Annual increase in the percentage of online courses using electronic textbooks or open educational resources

Proposed: TBD (*waiting for PBF Metric and Annual Report data on Textbook Affordability Action Plan*)



Affordability Performance Indicator and Goal: Working Collaboratively on Course Development

Current Performance Indicator:

SUS and Florida College System institutions collaborate on course design and development

Current Goal:

50% of SUS institutions are working collaboratively with institutions in the Florida College System to share online course development tasks and resources

Affordability Performance Indicator and Goal: Working Collaboratively on Course Development

Current Performance Indicator:

SUS institutions collaborate on course design and development

Current Goal:

50% of SUS institutions are working collaboratively with each other and/or with other universities to share online course development tasks and resources



Affordability Performance Indicator and Goal: Working Collaboratively on Course Design & Development

Proposed Performance Indicator:

SUS institutions collaborate on course design and development

Proposed Goal:

All universities offering online education work collaboratively to share online course development tasks and resources.



Affordability Performance Indicator and Goal: Working Collaboratively on Course Design & Development

Collaborative Course Development Tasks and Resources Underway:

- **STEM Labs Task Force** (*all 10 universities offering online education*)
- **Shared Languages Task Force** (*8 universities offering online education, plus New College*)
- **Florida CourseShare Initiative (“Master Courses”) Advisory Committee** (*all 10 universities offering online education, plus Florida Polytechnic*)
- **TOPkit** (*all 12 universities engaged in workshops, TOPkit Digest, and/or TOPkit site; 6 universities and 3 colleges serve on the Advisory Board*)
- **Course Design Review (“Quality”) Workgroup** (*all 10 universities offering online education, as well as 5 colleges*)



Affordability Performance Indicator and Goal: Innovative Strategies

Current Performance Indicator:

Competency-based and adaptive learning approaches reduce time-to-degree and associated costs.

Current Goal:

50% of SUS institutions offer competency-based or adaptive learning courses that accelerate student time-to-degree.



Affordability Performance Indicator and Goal: Innovative Strategies

Proposed Performance Indicator:

Innovative strategies, which may include but are not limited to competency credit and adaptive learning, will reduce time-to-degree and enhance student success.

Proposed Goal:

SUS institutions will utilize online education or innovative strategies to enhance student success.



Affordability Performance Indicator and Goal: Examples of Innovative Strategies

Florida Online Innovation Summit (9 out of 10 universities offering online education participated, March 2019)

- Innovation Track: Sessions included virtual reality, mobile technologies, virtual mentoring, digital badges, adaptive learning
- Research Track: Sessions included Adaptive Learning and Predictive Analytics
- General Session: Innovative student services and success strategies being employed in the SUS



Affordability Performance indicator and Goal: Examples of Innovative Strategies (*cont.*)

Complete Florida (7 out of 10 universities offering online education are currently partners, as well as colleges and ICUF institutions)

- Statutorily required to use existing and, if necessary, developing new competency-based instructional and evaluation tools.
- Established a networking group to review alternative credit and competency-based programming at partner colleges and universities.
