Professional Profile

TRUDY BLOCK

Trudy was elected to Polk City Council in April 2010. She was elected by her fellow councilors to serve as Vice Mayor from April 2010 through April 2012 and continues to serve as a City Councilor. Trudy volunteered to become the Acting City Manager/Vice Mayor in June 2010 and continued in that role for almost one year to lead Polk City through significant financial difficulties. She did so without compensation.

During her time as City Manager, Trudy's accomplishments included:

- 1. Decreasing the costs of the municipal operations
- 2. Restructuring the current debt
- 3. Outsourcing the operations of Polk City Utilities

Trudy was able to stop the city from going into financial collapse, dissolution, and/or bankruptcy with these measures and the approval of the City Council.

- Transportation Planning Organization
- Ridge League of Cities

Trudy served on the Florida League of Cities Finance and Taxation Committee in 2012. Trudy has completed the FLC IEMO Class and the Advanced IEMO Class for elected Public Officials. She has attended numerous other classes, the most recent was Building a Culture of Ethics.

Trudy was employed at Hewlett-Packard from April 1990 through retirement in April 2010. Trudy's roles included Global Account Manager managing programs with a team of local, offshore (China and India) and third party consultants.

Trudy was a Principal Consultant for over 2 years, selling and delivering consulting services in the Midwest Region. Trudy participated in the development and delivery of Information Technology solutions across the IT enterprise. During this time Trudy developed the HP Customer Relationship Management services methodology.

Trudy has significant technology experience leading teams in requirements gathering, change management, process, and governance. She developed the training tools used worldwide to assist consultants in passing the Masters ITIL exam and won awards for the work.

Trudy defined and implemented enterprise solution architectures. The architectures supported both the business and technical requirements.

From 1979 to 1989, Trudy worked as an RN years at Rush Presbyterian St. Luke's Medical Center in Chicago for 10 years.

Polk City, Previously Troubled, Gets Clean Audit

Examination finds finances are back on solid ground.

POLK CITY | After dealing with a string of problematic annual audits that highlighted Polk City's precarious financial situation, the City Council now has good news about its books..

It received a nearly perfect audit last week from Lakeland accountant Mike Brynjulfson.

Mayor Joe LaCascia credited Councilwoman Trudy Block for turning an insolvent city around. Block served as interim city manager for most of the 2010-2011 budget year.

"It's really good to see the year of my life I gave to my city is appreciated," a tearful Block said at the conclusion of the special meeting to review the audit for the year that ended Sept. 30.

The mayor said her service made the difference.

"It was the beginning of allowing good things to happen," LaCascia said.

Block served as the city's top executive from June 15, 2010, following the resignation of City Manager Cory Carrier, until May 2, 2011, when former City Manager Matt Brock began his four-month tenure.

When Block took over, Polk City faced a general-fund deficit of nearly \$500,000, not counting \$348,772 in defaulted loan payments to Polk County and another \$531,199 it owed the county for failing to pass on its share of impact fee revenue for several years.

In his fiscal year 2009 audit, Brynjulfson reported the city was technically insolvent, with a total budget deficit of \$881,068, including the general and utilities funds.

The 2011 general fund, which finances all city services except water and sewer, showed a balance of \$387,358, up from a deficit of \$420,912 in 2010.

The utilities fund ended the year with \$2.4 million in cash, up from \$224,147 in 2010, reflecting money not yet appropriated from a \$10 million bond issue.

Polk City also improved its performance in getting the annual audits in on time. They are due to the state within a year from the Sept. 30 closing of the fiscal year, but past audits missed that deadline by as many as five months because of the disarray in financial records.

"This year, it was really easy to do the audit — the easiest I've ever done," Brynjulfson told the council. "After all these years of pulling teeth at times, now we can just knock it out."

LaCascia and City Manager Patricia Jackson credited Finance Director Pam Lawson for cleaning up the city's books.

"We have allowed the finance director to do her job," Jackson said.

An independent audit after Carrier's resignation showed the city's impact fee debt stemmed from the former city manager improperly moving money to other city accounts.

Polk City did not escape Brynjulfson's latest audit entirely unscathed, however.

He cited the city for a significant accounting deficiency for failing to reconcile the utilities billing sub-ledger with the general ledger every month. Brynjulfson had cited the same deficiency in the 2009 and 2010 audit.

Lawson attributed the deficiency to a problem with the city's accounting software in dealing with credits and other adjustments some water and sewer customers get to their monthly bills. A clerk has to reconcile the adjustments manually, she said.

The clerk will get additional training to handle the reconciliations, Lawson said, and the city will try to upgrade its software.

Despite the ongoing issue, Polk City's accounting procedures have improved significantly when compared with the 17 deficiencies cited in the 2008 audit and 12 problems in the 2009 report, Brynjulfson said. Those included basic issues, such as not balancing the city's books with monthly bank statements.

"If you look back, they were very significant deficiencies," he said.

Ex-Acting Manager Baptized by Fire in Polk City

POLK CITY | Trudy Block has many of the qualities people would say they want in a public official: intelligence, compassion, respectfor opposing views and a tendency to study an issue first before taking a stand and to vote where the facts take her and not for personal or political gain.

That's why she may last only one term on Polk City's City Council.

Sure, people will say they want those qualities, but when those qualities lead a public official to take a stand opposite popular opinion — or at least the most vocal segment thereof — watch the venom fly. Block experienced that since joining the council in April 2010 and especially during nearly 11 months as acting city manager at the height of Polk City's debt crisis.

She stepped down after the council hired Matthew Brock as city manager earlier this yearbut retained her post as vice mayor. Her council term expires in 2014.

"The anger and name-calling is just unbusinesslike. If you've got a good reason, my mind can be changed. If you call me names, that doesn't help," said Block, a former information technology executive with high-tech company HP (Hewlett-Packard). "Why would you want to hurt people? This is a big problem. I know I'm naive."

As acting city manager, Block battled an effort led by a group called Concerned Citizens of Polk City to dissolve the city as a solution to paying off \$11 million in debt, including \$1.3 million owed to Polk County. The debt crisis had led former City Manager Cory Carrier to resign in June 2010.

In October, the group gave the council a petition signed by 396 people, equal to 43 percent of the electorate, to dissolve the city. The council rejected it on the advice of City Attorney Tom Cloud, who said state law did not allow for a municipal dissolution without a valid plan to pay off existing debt.

Concerned Citizens also supported a move to return the Mount Olive water and sewer system to the county, which had transferred ownership in 2008. The city was "hemorrhaging money," Carrier once told the council, to maintain the aging Mount Olive sewage treatment plant.

Block and Mayor Joe LaCascia led the fight against dissolution and returning Mount Olive to the county. The latter move, they argued, would put Polk City in even worse financial shape because it would lose revenue from the utility's roughly 1,100 customers while retaining all the accumulated debt.

"She stayed on her mission, which was first to attack the financial bleeding," LaCascia said. "I think we're going into this (2011-12) budget year with money in the bank, and a year ago we had a half-million-dollar deficit."

Nevertheless, Block and LaCascia became the focus of personal attacks on local blogs, including one run by Concerned Citizens.

Little in her background prepared Block for the vitriol of small-town politics.

'KNOWS HER OWN MIND'

Trudy Alice Block was born Nov. 21, 1952, the younger of two daughters of Frank Thomas Gray and Alice Mae Forsberg. Her sister, now Gail Funk, lives with her in Polk City while her new home two lots away is under construction.

Frank Gray was a locomotive mechanic and tester at the local General Motors plant and her mother was a housewife. The family lived in a typical middle-class, Midwestern suburb near Chicago's O'Hare International Airport.

Both parents passed along an intelligence gene, said Block's aunt, Marie Forsberg, 80, who lived in the O'Hare neighborhood before moving to Lakeland in March. But she got from her father a more scientific, analytical mind plus his work ethic.

Her mother taught Block a deep religious faith, which included the duty to serve others, and self-confidence, Forsberg said.

"I think she pretty much knows her own mind," the aunt said. "She pretty well knows what she wants in life."

Initially, that was a career in nursing, but after working for more than 10 years at a couple of Chicago hospitals, mostly in the operating room, Block switched careers.

Maggie Enich, 59, a friend since nursing school, described Block as a skillful, caring nurse, but the profession did not fulfill her creative, analytical side.

"Trudy wanted something different," Enich said. "Instead of being there to put in the pacemaker, she could help create it."

Engineering offered a fresh, intellectual challenge, Block said, and she doubted she could handle the physical demands of nursing into her middle age.

While still working as a nurse, Block studied at the Illinois Institute of Technology and received a bachelor's degree in electrical engineering in 1989. At a job fair soon after graduation, she stopped at the HP booth and learned the company was creating a new, computerized medical records system, which fit her background perfectly.

Block joined HP in April 1990 and rose to a management position in information technology, working out of the Chicago office but traveling frequently in the U.S. and abroad. She and husband William Block, who also has a career in information technology, moved to Polk City in 2008.

Working in a computer-based occupation allowed both Trudy and William Block to work out of their new home via the Internet, but she retired on April 30, 2010, almost exactly 20 years after joining HP and just weeks after joining Polk City's City Council.

NO 'RUBBER STAMP'

Block came to the council as an outsider after leading a successful effort to block expansion of the municipal sewer system to her Sandy Point neighborhood and two others in late 2009.

Notably, given the encounter with Concerned Citizens, Block led a petition drive against the sewer expansion that collected 322 signatures representing 244 properties, nearly a quarter of Polk City residences. Block and the other residents argued the expansion would cost them thousands of dollars more to connect to the new sewer lines plus pay the monthly sewer fees.

Councilman Don Kimsey, who also joined the council in April 2010, said Block's campaign against City Hall suggested to him and others she would support returning Mount Olive to the county and a dissolution referendum.

"She said what so many of us wanted to hear: There's no need for a citywide sewer system," said Kimsey, who has been on the minority end of several 4-1 votes on both issues. "She switched sides. I have no earthly idea why."

Block countered that she still does not support expansion of the municipal sewer system. Both the Mount Olive and dissolution issues center around the very different question of how to pay Polk City's debts, she said.

"He (Kimsey) has no solution" to paying off the debt, Block said.

Concerned Citizens has proposed dissolving the city and having the Polk County Commission create a special taxing district to pay off the debt. But no county commissioner has come out publicly in support of such a plan, one reason City Attorney Cloud rejected the dissolution petition.

Lisa Shifflett, a Concerned Citizens leader, declined to comment for this story.

Kimsey, no stranger to criticizing Block at council meetings, agreed the personal attacks were "uncalled for" and agreed she does her homework before speaking.

"Most assuredly, probably more so than anybody," he said. "She's not going to rubber-stamp something if she doesn't feel it's justified."

Mayor LaCascia agreed.

"I thought then (in 2009) and I think now she can be persuasive because she collects facts," he said. "Would I hire her again (as acting city manager)? Absolutely."

Polk City's Former Acting Manager Trudy Block Honored For Unpaid Work

POLK CITY | While Haines City residents debate former City Manager Ann Toney-Deal's \$312,430 severance deal, Trudy Block left more quietly as acting city manager in Polk City at the same starting salary more than 10 months earlier: \$0.

If you ask Block, however, she'll say she got the better deal.

The Polk City Council last week honored Block for her "outstanding leadership and dedicated service as the driving force behind the tough decisions to restore integrity and self-respect to Polk City," according to the plaque she received from her council colleagues and city managers from neighboring cities, Bobby Green of Auburndale and Doug Thomas of Lakeland.

"I was surprised" by the honor, Block, 58, said after the meeting. "My usual method is to be under the radar."

Council also honored City Clerk Patricia Jackson, a former Eagle Lake and Mulberry city manager before moving to Polk City in 2009, for helping Block, who had never held government office until her election to the City Council in April 2010. Jackson has worked more than 30 years in municipal government in Polk County.

"The accomplishments of Polk City governance during the past year could not have been achieved without your mentorship, knowledge, experience, loyalty and devotion," reads the plaque the council gave Jackson at the council meeting.

Polk City got more than its money's worth from Block during her difficult and sometimes controversial tenure running the city.

The council chose Vice Mayor Block to serve as acting city manager in June following the resignation of former City Manager Cory Carrier amid a financial crisis that surfaced in February 2010. At that point, the city's 2009-10 budget carried a debt of more than \$500,000, not including two defaulted loan payments of \$348,772 to the county and another \$531,199 owed on the county's share of impact fees.

Block had management experience as an information technology executive for 20 years with HP (formerly Hewlett Packard) in her native Chicago, and she was one of only two retired council members with time to put into the job.

Thomas recalled getting a call from Block shortly after she took the city manager's job, during which she acknowledged "I have no idea how to do this job," he said.

"I knew the business aspect, but I didn't know the government aspect," Block replied.

The budget deficit forced Block to make difficult cuts starting at the top with the layoffs of Assistant City Manager Pam Peterson, Public Works Director Gene Kniffin and another position. She also trimmed back the contract for law enforcement services with the Polk County Sheriff's Office from six officers to one, Sgt. John Conover.

Instead of hiring a replacement for Kniffin, the city signed a contract with Woodard & Curran, the Maine-based engineering firm, that saved an estimated \$272,061 in annual operations costs.

In all, Block said, she cut more than \$700,000 out of the Polk City budget last year and in the current 2010-11 fiscal year.

What attracted more public notice and considerable backlash was Block joining a council majority in June to raise water and sewer rates by 50 percent and votes in September to approve the current budget with a 12 percent property tax increase.

A citizens' group, Concerned Citizens of Polk City, in September submitted a petition with more than 700 signatures calling for a referendum to dissolve the city. Block was the target of more criticism when she backed City Attorney Tom Cloud, who advised such a referendum would be illegal without a valid plan to pay off Polk City's \$11 million debt.

But the low point of her tenure, Block said, was the refusal by county officials to end negotiations over the city's \$1.3 million debt. County officials threatened to sue the city, which forced the dispute into ongoing mediation.

The high point, she said, was hiring Block's successor, Matt Brock, who started on May 2.

"He's very smart. I think he'll be great for Polk City," Block said.
